- PROMOTION PERIOD:** The Tune Squad SWAG Drop (the “**Promotion**”) begins at 12:00 PM Eastern Time (“**ET**”) on March 21, 2026 and ends at 12:50 AM ET on April 7, 2026 (the “**Promotion Period**”). The Promotion Period consists of fifteen (15) separate non-consecutive Game Play/Entry periods (each a “**Drop Period**”). See chart in Rule #5 for details.
